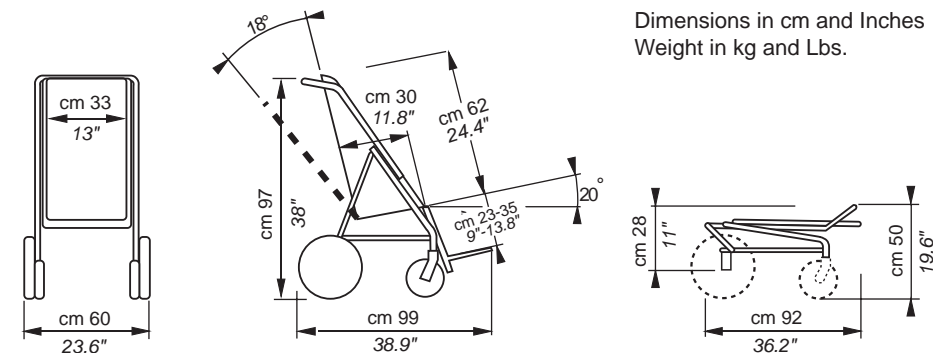


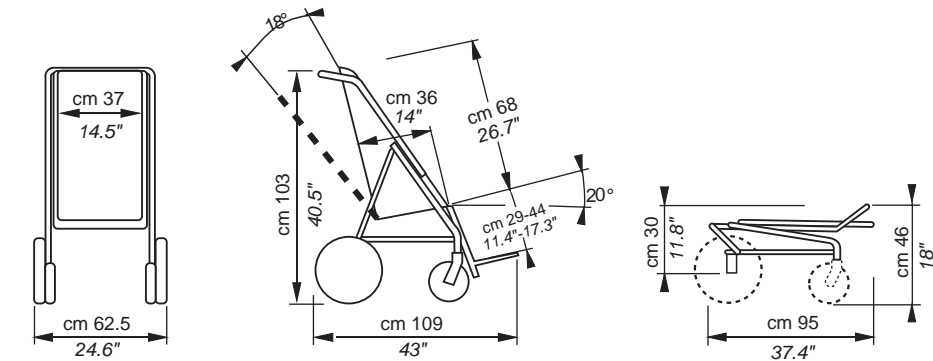

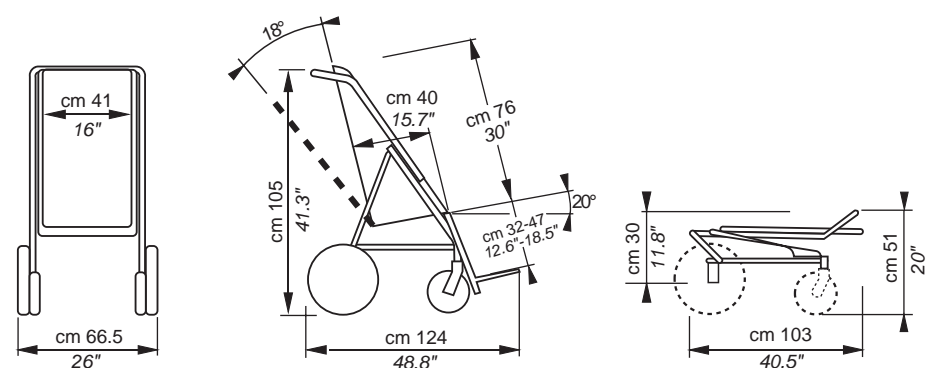

# ACCESSORIES

- Steel and aluminium **folding frame**, painted with non-toxic epoxy varnish
- **Trevira, padded, fire-retardant and removable upholstery**, machine washable at 30°
- **Chassis** made of natural-looking "cordura du pont" nylon, hard-wearing, washable



- 1 - slots for headrest
- 2 - slots for harness (853)
- 3 - side protections on the frame
- 4 - 828 chest belt (accessory)
- 5 - slots for abduction block
- 6 - quick release adjustment for the footrest
- 7 - adjustable tip-up footrest
- 8/9 - wheels sliding on ball bearings:  
front 17,5-cm. (7") swivel, unpierceable  
rear pneumatic 30-cm. (12") unpierceable rubber on request
- 10 - independent brake, light to use but hard wearing. No dangerous protuberances
- 11 - fold lock

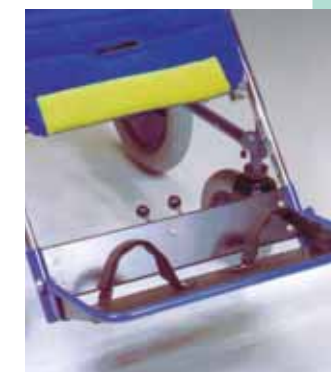

891 Set of 4 tie down hooks for the forward-facing transport of the pushchair in a motor vehicle (private vans/cars, buses..)

#### WARNINGS:

- fits the ISO 10542 compliant 4-POINT STRAP-TYPE TIEDOWN, provided by the vehicle
- it is required for the child to wear both pelvic- and shoulder-belt-type restraints, to be compliant either with ISO 7176-19 or ISO 10542. Postural belts and harnesses such as our 828, 853 and 894 are not approved for the use as an occupant restraint system, but they can be used in addition
- the vehicle must be suitable for transporting orthopedic pushchairs in compliance with current law
